Brothels banned in the Netherlands in 1911 to protect sex workers from exploitation.

Brothels were illegal, but tolerated until 1 October 2000: two articles were removed from the Criminal Code and the ban on brothels and pimping lifted.

Sex work has never been illegal in the Netherlands, provided it was voluntary.

Why was the ban on brothels lifted?

Aims:

- Control and regulate the business
- Protect the position of SWs, protect minors
- Decrease the link between sex work and crime
- Enhance safety in clubs, brothels: safe sex norm, fire department regulations, etc.
- Collect income tax

Legal context of sex work since 2000

- Sex clubs, brothels and escort services are legal businesses, but are subordinated to a local license system
- It is legal to run a business where men or women over the age 18 years old are voluntary employed as sex workers

Legal Context (2)

- The law was changed by the National government
- Local authorities (municipalities) formulate and implement policies on prostitution and are responsible for issuing licenses for brothels & clubs; regulation of management, regulation of premises

Safe Sex Policy

The majority of municipalities included the 'safe sex policy' into their license system:

- Brothels only can offer safe sex (otherwise they will lose their license)
- Brothels have to give easy access to health educators
- Brothels have to give sex workers the possibility to have medical check-ups
- Medical check ups have to follow the guidelines for STI control which means NO mandatory testing

State of affairs in the sex business

Facts and Figures

Before 2000 there were:

- About 1200 clubs and private houses
- More than 3000 window brothels
- Tolerance zones for street prostitution in the 4
- Biggest cities and in 4 province towns

In 2011 there are:

- Less than 450 clubs and private houses
 - Less than 1000 window brothels
 - 5 Regulated working areas for street prostitution
 - Increase in (private) escort
- The actual number is unknown: internet

Newly proposed law

In 2009 a new bill on sex work was formulated. *(with the purpose of combating human trafficking)*

Key issues:

- Mandatory registration for all sex workers
- Criminalization of clients
- National license system for internet & escort
- Age from 21 years

When sex work is forbidden (1)

Consequences for sex workers

- Hiding population
- Increased marginalisation and stigmatisation
- Increased risk of pimping
- Increased risk for blackmail
- Bad negotiation position towards clients

When sex work is forbidden (2)

Consequences for the health system

- Services not adapted to the needs of sex workers
- No confidentiality
- Problems in relation to payment/insurance

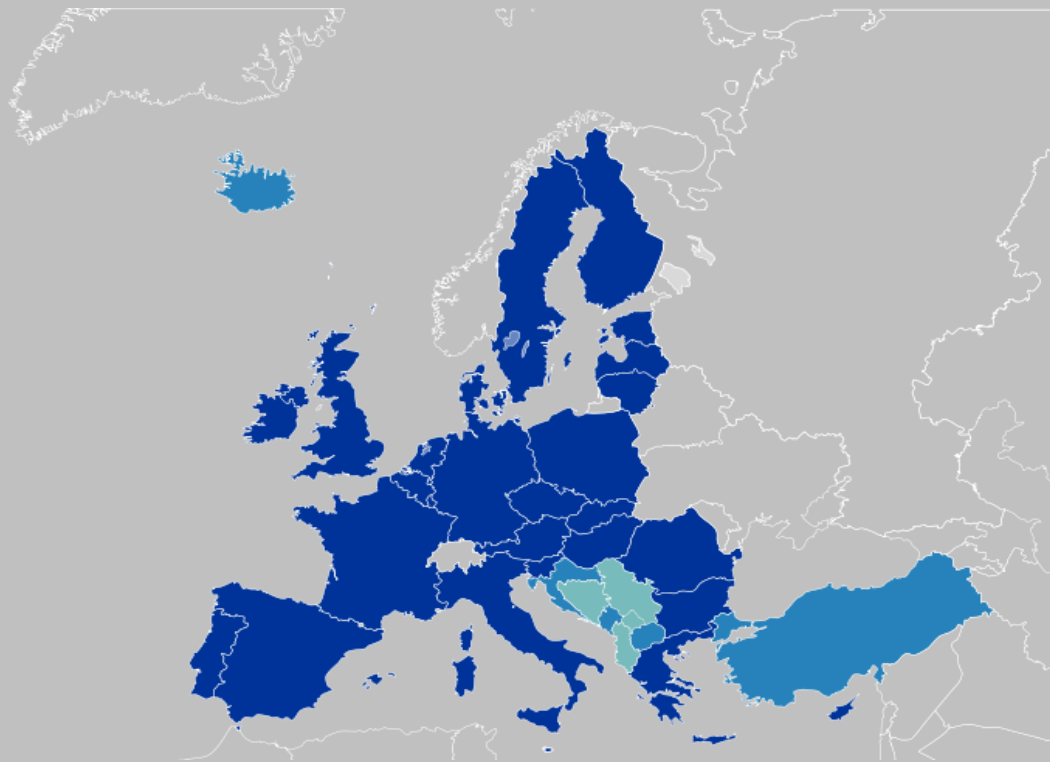
Consequences for sex workers

- Inadequate counselling and treatment

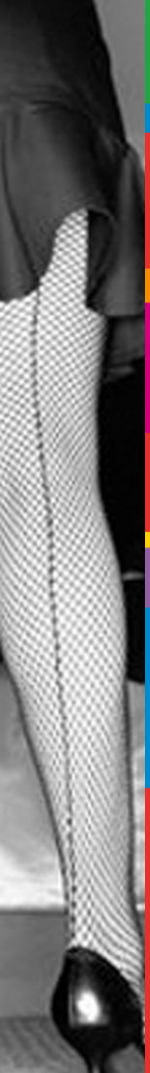

- Language
- Poor knowledge of social map
- Poor knowledge of sexual health
- Increase change of STI/HIV transmission
- High abortion rates

- Prevention

- Services are easy accessibility and free of charge; anonymous and flexible opening hours
- Outreach work, Peer education and informers in own language
- Chain partners and fast help: public health service providers, social work, cultural mediators, lawyers

Challenges

- The expansion of the EU will continue, This will effect the sex industry
- Migration is a human right
- Importance to reach the migrants and inform them about working conditions in the Netherland, ie sex work
- Gouvernments should take the responsibility for economical migrants
